## POLISH HERITAGE COMMITTEE

This committee meets at the Senior Center on the first Wednesday of each month from September through June. The aim of the committee is to document the history of the Polish immigrants who settled in Suffield. The Map Group has placed the homes of most of the immigrant families on a map of the town. They presented their work at the Show and Tell meeting. The Society received a \$2,500 grant from the Amiel P. Zak Public Service Fund at Hartford Foundation for Public Giving to copy photos of the immigrant families and to purchase archival materials for their storage.

The members are actively seeking information, photos, and memorabilia about each immigrant family. You can help by sharing names and addresses of descendants of these families. # Stony Brook CURRENTS

## Original Proprietors: Five Barber Men

Five Barbers were among the elite group of Suffield's original proprietors, and yet today little remains to mark their efforts in building and defending our town.

The first to arrive in 1674 were brothers John, Jr. and Thomas Barber from Springfield. They received adjacent grants of 50 acres each on Feather St. (now East St.), north of the current Bridge St. John Barber, Sr. received a 60-acre grant on Springfield Rd. (now Mapleton Ave.) in 1680. Two years later, freeman John, Sr. was elected one of Suffield's first selectmen.

The other two Barber land grants were given to Joseph and Benjamin, twin sons born to Thomas and his wife, Anne Chase<sup>1</sup>. The boys were the first twins born in Suffield and granted 40 acres in 1682 with the provision that their father "pay and discharge all rates and charges" until the "tyme they came of age." Thomas not only shouldered this responsibility but served as a sergeant in the militia and father to six other children.

But within the next few years, the story of this prominent and growing family takes a dramatic turn. Thomas died in 1689 and the following year his father and brother, John, Sr. and John, Jr. respectively, died as well. The twin son, Benjamin, also died in 1690 and was followed by his mother, Anne, in 1691. Quaker records from Salem County, New Jersey in 1691 show the names of three of Thomas's orphaned sons: Aquila, b. 1679; John, b. 1684, and Moses, b. 1867. The family of Anne Chase Barber had known Quaker connections, and it is probably this that led to their being taken in by the Salem Quakers.

Ten-year-old Aquila Barber had been apprenticed out to John Pynchon following his father's death, but was taken back by his mother shortly before her own death. Those Quaker records show Aquila prospered in New Jersey, purchased 1,500 acres in 1700 and later married Mary Graves. Together they were parents of eight sons and one daughter. Similar success was accorded to both John and Moses. But the Barber name had disappeared from Suffield town records completely.

## SUFFIELD VETERANS PROJECT

Launching a new Suffield Veterans History Project, volunteers are preparing to compile a database of local veterans and former military personnel whose names do not appear on the Suffield Veterans Memorial.

Residents past and present will be invited to apply for listing in the database, supplying such information as branch and dates of service, rank or specialty. Applicants will not need to have been residents at the time they entered or served in the military but they will be asked to supply their address(es) with pertinent dates of residence in Suffield.

Application forms will be available after September 1, 2008, at the library and the Town Clerk's office. In the meantime, inquiries may be sent to [suffieldvetshistory@gmail.com](mailto:suffieldvetshistory@gmail.com).

When names were gathered for the Suffield Veterans Memorial dedicated on November 11, 2003, space available on the monument limited the number of names which could be listed. To accommodate space limits, guidelines required that persons listed had to have been residents of Suffield at the time they entered the military. Space limits are not a concern for the database.

## HISTORICAL RECORDS PROJECT

The New England Historic and Genealogical Society is promoting a new project to search out private and other never-before-published genealogical records to be scanned, indexed, and made available to members on the Society's web site.

Art Sikes, a long-time member and a volunteer in the library's Historical Room, mentioned to Ralph Crandall, project director, the one-of-a-kind sources to be found in Suffield's collection. Mr. Crandall and two archivists have since visited the Kent Memorial Library and pronounced the archives a genealogical "gold mine."

Suffield's Library Commission is enthusiastic about the project, as scanning items from the collection has long been a goal. Extensive indexing will be a big plus. The library will get a copy of all work done, and costs will be born by NEHGS. The Suffield Historical Society trustees voted to support the project with a gift, as major fundraising is currently ongoing to fund this important initiative.
